Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (4) All mobile operations in the 2200-2290 MHz frequency band shall be limited to line-of-sight operations only.
- (5) Experimental stations shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number FA2487-19-F-5304. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
