- (4) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization Under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (5) Operation is subject to prior coordination with the incumbent licensees in the KaBand.
