This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Special Conditions:

- (3) A) NTIA wants to go on records stating that for the three locations the band 902-928 MHz is a radiolocation band with numerous other services used by the FCC and NTIA and is not a good band for command and control of a UAV's.
- B) For the Wallops Island, VA only the band M1386-M1387 can be used however future use of this band throughout the US will be difficult getting assignments on a permanent basis.
- C) For the Wallops Island, VA use of the band M1755-M1850 the user must coordinate prior to operations with Mid Atlantic Area Frequency Coordinator, Mike Ryan, 301-342-1194 or 1532 for times of use and frequency to be used due to numerous federal operations in the area. The bandwidth for this system is large and will be difficult to get permanent assignments.
- D) For Easton, MD site only the band M1386-M1387 can be used however future use of this band throughout the US will be difficult getting assignments on a permanent basis.
- E) User should advise the DoD user to submit this system to the MCEB and SPS if they plan to purchase.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number W9113M-07-D-0008, Task Order 0016. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
