- (1) One or more frequency assignments were coordinated prior to authorization with FAA Headquarters, 800 Independence Avenue, S.W., Washington, DC 20591; Telephone: 202-267-8699.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee should be aware that Federal Aviation Administration stations may be licensed on the frequencies 1025 MHz, 1060 MHz and 1095 MHz, and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Air Force contract number DAAB07-03-D-B006/0020. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) Operation in 1090 MHz is not permitted . For future reconsideration, a modification application must be filed.
