- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by U.S. Air Force contract number F33657-00-G-4029, Randtron subcontract number 4500258387. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Operation requires consent of affected existing Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
- (6) This frequency assignment in the bands 2310-2320 and 2345-2390 MHz was coordinated prior to authorization with the Western Area Frequency Coordinator (WAFC) who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the WAFC as necessary to ensure compatibility with existing uses.
- (7) Operation is subject to prior coordination with the Satellite Digital Audio Radio System (SDARS) and Wireless Communications Service (WCS) licensees within 25 miles of test area.
