This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (5) Experimental licensee is subject to notifying the following within 50 miles of the test area:
Location & Monitoring Service licensees (902-928 MHz).
- (6) Prior to the start of operations at the Draper, Utah location, L-3 Communications must contact the Utah Test and Training Range (UTTR) Spectrum Manager and provide a STOP BUZZER POC in case interference is experienced.
