- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

- (5) Operation is subject to consent of Cellular and Narrowband PCS (901-902 MHz) licensees within 25 miles of the locations of the test.
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number W15P7T-10-D-D420. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization Under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (8) This license SUPERSEDES the previously issued license with the same call sign and file number: to amend Special Condition (5).
