- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Operation is subject to prior coordination with Fixed Microwave licensees in the 2110-2180 MHz band, and with Local TV Transmission licensees in the 2025-2110 MHz band.
