- (2) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) Coordinate with the Educational Broadband Service and Broadband Radio Service licensees prior to operation in 2500-2690 MHz band.
- (7) Coordinate with the SBE frequency coordinator prior to operation in 921-960 MHz band.
- (8) Operation subject to consent of the following within 50 miles of the test area:
 - SMR licensees (809-824 MHz/854-869 MHz)
 - SMR licensees (896-901 MHz/935-940 MHz)
 - Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
