- (2) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) L3 Technologies coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation on 153.005 MHz, 157.53 MHz, 158.34 MHz, 159.63 MHz, 159.975 MHz, 452.35 MHz, 452.625 MHz, 452.975 MHz, and 456.5 MHz.
- (7) Operation must be consented with the following within 50 miles of the test area:
 - o SMR licensees (809-824 MHz/854-869 MHz)
 - o SMR licensees (896-901 MHz/935-940 MHz)
- (8) Operation is subject to notification of the following within 50 miles of the test area:
 - o Paging Service licensees in 152 MHz
 - o Paging Service licensees in 158 MHz
