- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) All operations must be prior coordinated with WAFC at (760) 939-6948.
- (5) Operations will be restricted to pulse repetition rates (PRR) between 2,099 and 13,889 pulses per second.
