Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (4) Coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation on the frequencies from 153.005 MHz to 159.975 MHz, and 452.35 MHz to 452.975 MHz.
- (5) The licensee must obtain consent from the following within 50 miles of the contours of the testing area:
 - Paging Service licensees in 152 MHz
 - Paging Service licensees in 158 MHz
 - Paging Service licensees in 152 MHz/158 MHz
 - SMR licensees (809-824 MHz/854-869 MHz)
 - B/ILT licensees (809-824 MHz/854-869 MHz)
 - SMR licensees (896-901 MHz/935-940 MHz)
 - B/ILT licensees (896-901 MHz/935-940 MHz)
