- (6) Operation is subject to coordination with the Eastern Area Frequency Coordinator located at Patrick AFB, Florida, prior to use within the area bounded by 24 N 31 30'N and 77 W 82 W2.
- (7) Operations on this assignment are subject to immediate cessation, if it causes harmful interference to EPA Coastal OPS Assignments.
