- (5) Operation is subject to notification of the following within 50 miles of the test area:
 - Paging Service licensees in 454 MHz/459 MHz
 - General Aviation Air-Ground Service in 454 MHz/459 MHz
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract numbers W15P7T-17-D-0103, W58RGZ-20-C-0024. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) Stop Buzzers are David West (423) 836-8325, and Clarence Simpson (540) 831-0261.
- (8) Operations in the band 420-470 MHz under the authority of this license are subject to immediate adjustment, including cessation, if they result in harmful interference to the NASA Firefly satellite system.
- (9) Operation is subject to coordination prior to activation and, as appropriate, possible scheduling with Christine Plumley, cplumley@nrao.edu or 304-456-2270., when used within 20 nautical miles of the National Radio Quiet Zone.
- (10) Operation is prohibited on 449.75-450.25 MHz band.
