Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) GPS re-radiators are limited to a maximum ERP value that will result in power levels not to exceed a power spectral density of -140 dBm/24 MHz measured at a distance of 100 ft outside the building of operation. Any malfunction, misalignment, or tampering of the equipment or its location which results in an increased power spectral density outside the building could cause harmful radio frequency interference to GPS receivers, including those in aircraft and/or ground based facilities.
- (5) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (6) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract numbers W909MY-12-D-0008 and W15QKN-14-9-1001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (8) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (9) The test equipment shall only be used indoors and shall be under the control of Leidos, Inc.
- (10) Leidos, Inc. shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (11) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (12) The designated point-of-contact to terminate transmissions if interference occurs is Jonathan Wetherbee at (256) 503-6976.
- (13) Operations in the following frequencies 1575.42 MHz and 1176.45 MHz may support Independent Research & Development (IR&D).
- (14) This license SUPERSEDES the previously issued license with the same call sign and file number: to update Special Condition 7.
