Consent to Use of EBS Station WLX824

Dear Mr. Wachterhauser:

Delaware Valley Educational Television Network Inc. ("DVETN") is the licensee of EBS Station WLX824. Station WLX824 is subject to a de facto transfer lease with Clearwire Spectrum Holdings II, LLC, which is a wholly-owned subsidiary of Clearwire Corporation ("Clearwire"). Lockheed Martin Corporation ("Lockheed Martin") has requested the temporary use of DVETN's A3 spectrum (002513.00000-002518.00000 MHz) (the "Spectrum") from September 1, 2009 through August 31, 2010.

Clearwire supports Lockheed Martin's proposed testing, and pursuant to the lease between DVETN and Clearwire, Clearwire is requesting DVETN's consent to Lockheed Martin's use of the Spectrum for one year in association with an application for Experimental Authority to be filed with the Federal Communications Commission ("FCC").

By its signature below, DVETN hereby consents to Lockheed Martin's use of the Spectrum for the period specified above to demonstrate the capabilities of 4G wireless broadband services to the Federal Government.

Lockheed Martin agrees to operate on the Spectrum in accordance with the rules and regulations of the Federal Communications Commission, and to take all necessary steps to cause no interference to any current operations and to protect and preserve the status of the License and Lease associated with the Spectrum. There will be no commercial use of the spectrum pursuant to this experimental application. Without limiting the foregoing, Lockheed Martin agrees that in the event of interference, it will immediately cease any use of the Spectrum upon written notification from DVETN, until any interference issues that might arise are resolved to your satisfaction.

Clearwire believes that DVETN's consent to this trial will benefit it and other EBS licensees and will encourage the parties to promote these benefits to other EBS licensees. The parties acknowledge that this letter will be attached to the application for Experimental Authority to be filed by Lockheed Martin with the FCC's Office of Engineering and Technology.
