This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

- (4) The designated points-of-contact to terminate transmissions if interference occurs are: (607) 751-4284 and (607) 206-0097.
- (5) Operation is subject to prior coordination with incumbent licensees within 500 KM from center of coordinates on the license.
- (6) Licensee must comply with the FCC CFR 47, Part 25 rules.
- (7) The licensee must record the location (latitude/longitude/altitude), at intervals of not greater than 1 minute while the experimental station is transmitting. The licensee shall make this data available within 24 hours of a request from the Commission.
- (8) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization Under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
