Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The transmission is limited to the direction of 115-170 degrees and 195-210 degrees referenced to true North.
- (5) Operation is limited to pulse duration of 25-2000 microseconds and pulse repetition rate of 500-10000 PPS.
