- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (4) Lockheed Martin Corporation must comply with the terms of any L-band satellite operator-to-operator coordination agreement. In the absence of a continuing L-band operator-to-operator coordination agreement, operations of METs in the 1525-1559 and 1626.5-1660.5 MHz bands will be on a non-harmful interference basis until a future operator-to-operator agreement is concluded. In this instance, each licensee must notify the other operators in these frequency bands that it will be operating on a nonharmful interference basis.
- (5) Prior to commencing operations, Lockheed Martin shall coordinate its use of the band 1626.5-1660.5 MHz with LightSquared and Inmarsat MSS operations.
