- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (4) Operation in the 1910-1930 MHz band requires coordination with UTAM, Inc. pursuant to Section 15.307 of the Commission's Rules.

- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by US Navy contract number N00024-96-C-6332. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) All operations on frequencies in the 1850-1990 MHz and 2450-2483.5 MHz bands must be prior coordinated with existing fixed microwave stations in accordance with 47 CFR, Part 101.103(d).
- (8) This license SUPERSEDES the previously issued license with the same call sign and file number: removes the emission designator 16M0G1D from the 30-32.5 MHz band at the West Palm Beach, FL location.
