Special Conditions:

- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by contract numbers M67854-00-C-2049, M67854-05-D-2002, and M67854-00-C-2008. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) The authorized emission bandwidths shall be located within the bands so that they do not extend beyond the upper or lower limits of the authorized bands.

- (6) For the Cazenovia (FX/MO) location NL 42-55-37; WL 75-55-27, operations on 1353-1392 MHz will be in accordance with the following: PRR = 1-1000 pps, and pulse duration = 2 us and ERP = 241/258 MW peak, respectively. TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 0-40 DEG, and 95-105 DEG, and 160-195 DEG, and 260-360 DEG REF TO TRUE NORTH.
- (7) For the Cazenovia (FX/MO) location NL 42-55-37; WL 75-55-27, operations on 1264-1286 MHz will be in accordance with the following: PRR = 1-1000 pps, pulse duration = 2 us and ERP = 241/258 MW peak, respectively. TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 5-15 DEG, and 178-188 DEG REF TO TRUE NORTH.
- (8) For the Syracuse (FX/MO) location NL 43-06-44; WL 76-11-18, operations on 1353-1392 MHz will be in accordance with the following: PRR = 1-1000 pps, pulse duration = 2 us and ERP = 241/258 MW peak, respectively. TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 0-45 DEG, and 100-110 DEG, and 160-188 DEG, and 255-360 DEG REF TO TRUE NORTH.
- (9) For the Syracuse (FX/MO) location NL 43-06-44; WL 76-11-18, operations on 1264-1286 MHz will be in accordance with the following: PRR = 1-1000 pps, pulse duration = 2 us and ERP = 241/258 MW peak, respectively. TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 5-15 DEG, and 178-188 DEG REF TO TRUE NORTH.
- (10) For the East Syracuse (FX/MO) location NL 43-05-23; WL 76-05-53, operations on 1353-1392 MHz will be in accordance with the following: PRR = 1-1000 pps, pulse duration = 2 us and ERP = 241/258 MW peak, respectively. TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 10-20 DEG REF TO TRUE NORTH.
- (11) For the East Syracuse (FX/MO) location NL 43-05-23; WL 76-05-53, operations on 1264-1286 MHz will be in accordance with the following: PRR = 1-1000 pps, pulse duration = 2 us and ERP = 241/258 MW peak, respectively. TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 3-13 DEG, and 180-190 DEG REF TO TRUE NORTH.
