Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government Contract Numbers: FA8706-09-C-0004, FA8720-05-C-0002; and Foreign Contract Numbers: FK 2005-10 , LVQ2TPS77. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Pulse Repetition Rate = 0 , and Pulse Duration = 2.0
- (6) Transmission required to be blanked between 2-12 degrees reference to True North.
