Special Conditions:

- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) A pulse repetition rate of 164 pps is specified for the use of the frequency 1030 MHz.
- (6) Pulse duration of 0.8 microseconds is specified for the use of the frequency 1030 MHz.
- (7) The designated point-of-contact to terminate transmissions if interference occurs is Jeff Marier, Phone (315) 456-4038.
- (8) Operation is limited to SIF mode1, 2 , 3A , C.
- (9) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number FA8217-11-C-0005 , FA8730-14-C-0030, 4100627880 , and ADATS/228. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
