- (1) All operations subject to prior coordination with Area Frequency Coordinator Pacific Missile Range, Point Mugu, California: (805) 989-7983.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Contract Numbers: DP-A3994P6631, FA8615-05-C-6002 , FA8615-10-C-6051 , and FA8615-07-C-6034. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) All operations will be outside of the U.S./Canada Border Zone, or for assignments for frequencies below 1000 MHz the power used while operating in the Border Zone will not exceed 5 watts.
- (7) Subject to coordination prior to activation and, as appropriate, possible scheduling with the WSMR Area Frequency Coordinator located at (575) 678-1510 when operations are within 50 kilometers of White Sands Missile Range, New Mexico.
- (8) Licensee should be aware that US Air Force operations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (9) All operations subject to coordination with the Gulf Area Frequency Coordinator located at Eglin AFB, Florida, phone (850) 883-7535; AFC located at Nellis AFB, Nevada, phone (702) 652-3417; AFC located at Pax River, Maryland, phone (301) 342-1194; and AFC located at China Lake, California, phone (760) 939-6948.
- (10) Coordination with NASA White Sands Center (WSC) is required at least 7 days in advance with the NASA WSC POC as designated by the NASA/GSFC spectrum manager, Scott Galbraith at (301) 286-5089. For operations within 3 days, may coordinate with the NASA-WSC operations center at (575) 527-7157.
