- (1) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Special Conditions:

- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) FirstNet can request the FCC to order the licensee to cease operations within 24 hours.
- (5) Operation is subject to the following conditions:
 - 1. Secure consents from the AWS licensees prior to accessing to 2120-2200 MHz.
 - 2. Coordinate with the local SBE frequency coordinator prior to operation in 57-57.5 MHz, 69-69.5 MHz, 152-153.5 MHz, 159-160.5 MHz, 166-167.5 MHz, 2410-2500 MHz and 5450-7000 MHz
 - 3. Coordinate with the Fixed Microwave Service licensees prior to operation in 900-940 MHz, 2410-2500 MHz, 5450-7000 MHz and 9600-12000 MHz.
- (6) Operation is subject to notification of 152 MHz Paging licensees within 25 miles of the locations of the test.
