- (2) Operation is subject to prior coordination with the Associated Public Safety Communications Officers, Inc. (APCO); ATTN: Director of Frequency Coordination; 351 North Williamson Blvd.; Daytona Beach, FL 32114-1112; Telephone: (386) 322-2500.
- (3) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (4) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.

Special Conditions:

- (5) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (6) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (7) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (8) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (9) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (10) Operation is subject to prior coordination with the existing and future Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d).
- (11) Licensee is subject to prior coordinate with affected public safety operators along the US/Canadian border.

- (13) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract numbers: N68786-06-C-6205 , and N68786-11-C-5413. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above
- (14) Operation in frequency band 1427-2025 is subject to prior coordination with the U.S. Air Force coordinator in Alexandria, VA.
- (15) Secure consents from the AWS licensees prior to accessing to 1427-2015 MHz band. This includes AWS licensees in the following bands:
