- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Army; contract number W31P4Q-15-D-0040. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) The army and applicant are aware that if this system becomes operational, the assignment in 4400 MHz band must comply with 4.3.18 of the NTIA manual.
