The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) Due to auxiliary broadcast stations within 100 km of the areas above, operation is subject to prior coordination with the Society of Broadcast Engineers, Inc. - (7) Operation is subject to prior coordination existing point-to-point microwave users within 100 km of the areas above in accordance with 47 CFR Part 101.103(d) for use of the frequencies between 2450 and 2484 MHz.
- (8) The requested 2.4 GHz band includes 802.11 and Bluetooth uses, and Lockheed Martin needs to ensure that the high power does not cause interference to the public.
- (9) This license SUPERSEDES the previously issued license with the same call sign and file number: completes emission designators.
