Special Conditions:

- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operations on 1030 MHz for the coordinates NL 43-06-43, WL 076-11-18 will be in accordance with the following restrictions:
 - a) PRR = 175 pps
 - b) Pulse Duration = FX 0.8 usec
 - c) Radius of operation = 1 kilometer
 - d) Only modes 3A and C are allowed to transmit
 - e) Interrogation must be between 225 and 316 degrees referenced to True North. All other angles must be blanked.
- (5) Operations on 1030 MHz for the coordinates NL 43-05-20, WL 076-05-53 will be in accordance with the following restrictions:
 - a) PRR = 175 pps
 - b) Pulse Duration = FX 0.8 usec
 - c) Radius of operation = 1 kilometer
 - d) Only modes 3A and C are allowed to transmit
 - e) Interrogation must be between 225 and 316 degrees referenced to True North. All other angles must be blanked.

Special Conditions:

- (6) Operations on 1030 MHz for coordinates NL 42-55-37, WL 075-55-27 will be in accordance with the following restrictions:
- a) PRR = 140 pps
 - b) Pulse Duration = FX 0.8 usec
 - c) Radius of operation = 1 kilometer
 - d) Only modes 1/2/3A/C are allowed.
 - e) Interrogation must be between 230 and 316 degrees referenced to True North. All other angles must be blanked.
