Special Conditions:

- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Operations will be in accordance with the following restrictions:
 - a) PRR = 1400 pps
 - b) Pulse Duration = 2 usec
 - c) Radius of operation = 1 kilometer
 - d) Transmission is permitted in 30-60 degrees reference to true north. Blanking is required in all other directions.
 - e) No IFF operation associated with the radar.
