- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Coordinate with the existing and future Fixed Microwave Service licensees prior to operation in 4000-4200 MHz, 5925-6425 MHz and 6425-6875 MHz in accordance with 47 CFR, Part 101.103(d).
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract numbers: FA8682-10-C-0016 and HR0011-09-C-0096.. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) In accordance with the FCC CFR 47, Part 25, licensee is required to prior coordinate operations with affected existing and future licensees in the area to avoid interference.
- (8) In accordance with the Table of Frequency Allocation footnote US 261, operation in the band 4200-4400 MHz is not permitted.
