Special Conditions:

- (1) Operation on frequency assignments in one of the bands 1435-1535 or 2310-2390 MHz was coordinated prior to authorization with the Western Area Frequency Coordinator (WAFC), Point Mugu, CA, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the WAFC as necessary to ensure compatibility with existing uses.
- (2) Assignment in frequency bands 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Western Coordinator, Los Angeles, CA. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Western Coordinator, Los Angeles, CA, as necessary to ensure compatibility with existing uses.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (6) Operation in 1625-1755 MHz is subject to coordination with the Western Area Frequency Coordinator (WAFC), at Phone: (760) 939-6948.
- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number H92254-09-D-0001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (8) Secure consents from the AWS licensees prior to accessing to 1625-1850 MHz and 1670-1700 MHz bands.
- (9) Coordinate with the local SBE frequency coordinator and the Fixed Microwave Service licensees prior to operation in 2345-2500 MHz bands. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.
- (10) Operation must not exceed 1400 ft. AGL.

Special Conditions:

- (11) Operation in 2496-2500 MHz requires consent of affected Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
