- (1) Assignment in frequency bands 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Southern Coordinator, Atlanta, GA. - (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract numbers FA8682-10-C-0016 and HR0011-09-C-0096. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) The direction of radiation is 147 degrees reference to True North (TN).
