- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.

- (6) Operations on 1271-1279 MHz will be in accordance with the following:
TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 2-12 DEG, and 177-187 DEG, and 241-251 DEG REF TO TRUE NORTH.
- (7) Operations on 1363-1381 MHz will be in accordance with the following:
TRANSMISSIONS ARE REQUIRED TO BE BLANKED BETWEEN 2-12 DEG, and 97-107 DEG, and 177-187 DEG REF TO TRUE NORTH.
- (8) This license SUPERSEDES the previously issued license with the same call sign and file number: adding special conditions (6) and (7).
