Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) No interference shall be caused to government operations co-channel in Boston, MA using 2 watt hand held radios.
- (5) LoJack Corporation shall develop and test this equipment for export only.
- (6) LoJack Corporation is to understand that the frequency 164.175 MHz is an exclusive federal allocated frequency and no non-government use will be authorized beyond testing for international licensees.
- (7) LoJack Corporation must be aware that future testing on this frequency may be denied due to expanding government use of the frequency 164.175 MHz and that FCC or shared bands should be in considered in the future.
- (8) Operation is subject to prior coordination with affected existing and future Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d).
- (9) LoJack equipment developed on this frequency or any frequency other than 173.075 MHz shall not be sold in the United States nor its Possessions.
