Based on the ex parte letter submitted in ET Docket No. 98-206 on Nov. 7, 2003 by counsel for MDS America, it appears that on Nov. 5, 2003 a jury verdict was rendered in favor of MDS America and adverse to the patent claims of Northpoint in Northpoint Technology, Ltd. v. MDS America, Inc., Case No. 01-14207-CIV-COHN (So. D. Fla., W. Palm Beach Div., filed Jul. 18, 2001). Counsel is hereby requested to supplement the record by documenting the court's verdict (such as may be obtained through the PACER system), submitting a copy of all relevant subsequent rulings of the court, and by setting forth the status of the litigation (e.g., finally adjudged, appeal pending, etc.). 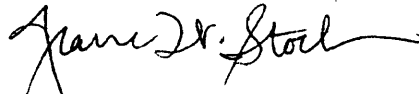
We file this letter on behalf of MDS America, Incorporated ("MDSA") to supplement MDSA's letter of March 26, 2003 and the letter of Northpoint Technology, Ltd. ("Northpoint") of that same date regarding the status of the patent litigation case, *Northpoint Technology, Ltd., v. MDS America, Inc. and MDS International, S.A.R.L.*, Case No. 01-14207-CIV-COHN (S.D. Fla.). Northpoint's letter stated that it "writes separately [from MDSA] to emphasize the narrowness of the jury's verdict, which affects only three of the 35 claims of the two patents in suit."

MDSA strongly disagrees with Northpoint's improper narrowing of the scope of the verdict with respect to the Northpoint patents at issue – Patent Nos. 5,761,605 and 6,169,878 (the "Patents"). While this Commission is not the proper forum to provide a detailed rebuttal to Northpoint's letter, Northpoint's mischaracterizations must be corrected.

In the litigation, Northpoint elected to prosecute its patent infringement claims by presenting three claims that it characterized as "representative" of all of its claims. In so doing, Northpoint chose not to separately put its other 32 claims before the jury. Northpoint and the District Court recognized that the validity of the Patents would stand or fall based on the three representative claims presented by Northpoint. Consequently, the jury's verdict resulted in all claims under the Patents being deemed invalid. Northpoint's attempt to back away from the decision it made at trial is troubling and its assertions that its other claims survive is simply erroneous.
