- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) No transmissions are permitted on 156.8 MHz and 243 MHz.
- (4) The designated point-of-contact to terminate transmissions if interference occurs is Victor Tang at (510) 214-4451.
- (5) No transmissions are permitted on the following frequencies plus and minus 12.5 kHz from each center frequency:

Center Freq: 345.000 MHz, notch out: +/- 12.5 kHz
- (6) The testing will be conducted inside an enclosed building.
