Special Conditions:

- (1) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operation must be consented by the following licensees within 50 miles of the test area:
 - *SMR licensees (809-824 MHz/854-869 MHz)
 - *Cellular licensees (824-849 MHz/869-894 MHz)
 - *Location & Monitoring Service licensees (902-928 MHz)
- (5) This STA shall not be renewed beyond the set date. A conventional application must be filed for further operation.
