- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Prior to commencing any operations in the frequencies below, the licensee must obtain consent from the following within 50 miles of the contours of the testing area: Paging Service licensees in 43 MHz
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number NA16NOS0120025. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) This license will not be renewed.
