Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) All of the experimental devices will be under control of Microsoft Corp. and they will be retrieved by Microsoft Corp. from the participants upon completion of the experiment.
- (3) Microsoft Corp. must prior coordinate and obtain consent from the local Advanced Wireless Service (AWS) licensee(s) in 2110-2130 MHz band to avoid interference.
- (4) Operation in the 1980-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensee(s) to avoid interference.
- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) Microsoft will be responsible for ensuring that the devices are used in authorized locations and in a manner authorized.
- (7) Microsoft should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (8) Under this authorization, the total number of experimental devices shall not exceed 2000 units.
