- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Air Force Life-Cycle Management center, Contract Number FA8702-21-C-0001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Point of Communication: Galaxy 17 @91 WL (call sign S2715) operating in the 5925-6425 MHz band.
- (6) For operations in the 5925-6425 MHz band, the authorized power (ERP) and EIRP (dBW) of the authorized experimental Comtech antennas must not exceed 102.3W (ERP) and 22.2 dBW, respectively.
