Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Maintain operation separation from the grandfathered earth stations as defined in Part 90, subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (4) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the area.
- (5) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
