Special Conditions:

- (1) Following launch of the satellite, the licensee must notify the FCC through electronic submission to the license file, of the status of the satellite (transmissions commenced, etc.), not later than 7 days after commencement or expected commencement of transmissions, and of termination of transmissions, not later than three months after such termination.
- (2) Upon receipt of a conjunction warning from the JSpOC or other source, the licensee must review the warning and take all possible steps to assess and, if necessary, to mitigate collision risk, including, but not limited to: contacting the operator of any active spacecraft involved in such warning; sharing ephemeris data and other appropriate operational information with any such operator; modifying spacecraft attitude and/or operations.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) POINT OF COMMUNICATION: RADSAT-G CubeSat.
