- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operation is subject to notification of the following within 50 miles of the test area:
 - Narrowband PCS licensees (901-902 MHz)
 - Location & Monitoring Service licensees (902-928 MHz)
- (5) Coordinate with the local SBE frequency coordinator prior to operation in 186-198 MHz and 510-550 MHz bands.
- (6) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
