- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) No WiMAX equipment in the band 3300-3650 MHz will be offered for U.S. sales.
- (4) No equipment shall be developed in this band for use in the U.S. since it is a federal government band for radiolocation. Any development for use in the U.S. needs to be done in an approved FCC band. WiMAX should not be developed in the band 3300-3650 MHz for U.S. sales.
- (5) Motorola, Inc., needs to be aware of possible interference from high power government radars in the band 3300-3650 MHz.
- (6) This authorization is for equipment that is intended for export only.
