Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Maintain separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate and agreement with the grandfathered earth station licensees prior to accessing to 3650-3700 MHz.
- (5) Ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in each proposed area.
- (6) The transmit power is limited as prescribe in 47 C.F.R. §96.41 to ensure compatibility with incumbent FSS operators in the 3600-3700 MHz band.
- (7) Transmitters must comply with earth station protection requirements established in 47 C.F.R. §96.17 (a) and 47 C.F.R. §96.17 (f).

Special Conditions:

- (8) Motorola Solution Inc. must notify all earth stations within 40 km of the locations cited in this grant. The notice must include Motorola's stop buzzer point of contact information to notify the testing operator(s) to shut down in case of interference. The notification should also include the testing parameters, the day and times of each test. Consult MyIBFS database in the FCC.GOV website to identify all existing license FSS earth stations in the 3600-3700 MHz band.
- (9) Ensure that the transmitting station antenna(s) tilt downward when possible to protect satellite earth stations nearby.
- (10) Prior to the start of operations in the 3625 -3700 MHz band, licensee must notify the National Spectrum Managers Association (NSMA) frequency coordinator by e-mail. This notice must include the name and contact information of the stop buzzer personnel. It must also include the testing parameters, day and times of each testing.
