Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (4) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."

Special Conditions:

- (5) Licensee is required to file a PROGRESS REPORT every 6 months from the date of grant. This progress report shall be filed with Federal Communications Commission; Experimental Licensing Branch, MS 1300E1; 445 12 Street, S.W.; Washington, DC 20554.
- (6) Licensee is authorized to operate up to 1000 unapproved devices at the Maitland, FL location.
- (7) Licensee is authorized to operate up to 1000 unapproved devices for demonstration purposes only on a nationwide basis. No more than 200 devices may be operated at a time for each demonstration.
- (8) Operations in the 2.5-2.686 GHz band shall provide interference protection, in accordance with 47 CFR, Part 27.1221, to existing co-channel and adjacent channel BRS and EBS operations. Alternatively, concurrence must be obtained from those potentially affected licensees prior to operation.
- (9) Operations in the 4.94-4.99 GHz band must be coordinated with the existing and future users to avoid interference.
- (10) Operating powers in the 2.4-2.4835 GHz and 5.725-5.875 GHz bands must comply with the limits authorized under Part 15 of the FCC rules.
- (11) This license SUPERSEDES the previously issued license with the same call sign and file number: adds Maitland, FL coordinates and tolerance condition, and amends Part 15 and Part 27 conditions.
