Special Conditions:

- (3) Licensee must avoid transmissions that will cause interference to government operations on 217.5220, 217.5521 and 217.5528 MHz within the proposed Mount Lukens (Los Angeles) operating area.
- (4) This authorization SUPERSEDES the previously issued authorization with the same call sign and file number: adds frequencies to all locations.
