Special Conditions:

- (1) The station identification requirements of Section 5.152 of the Commission's Rules are waived.
- (2) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (3) All use on frequencies assigned to public safety licensees should be coordinated with the designated land mobile public safety coordinator.
- (4) All use on frequencies that are assigned for use by stations in the fixed microwave service should be prior coordinated with existing operations in accordance with Section 101.103(d).
- (5) All use on frequencies that are assigned for use by stations the broadcast auxiliary service should be coordinated with the local broadcast coordinator.
