Special Conditions:

- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (4) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (5) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed geographic areas.
